### What information we collect, use, and why

We may collect or use the following types of information for the purposes of services relating to learner education and welfare:

- Names and contact details for learners
- Gender
- Pronoun preferences
- Date of birth
- Next of kin and emergency contact information
- Payment details and financial information including transactions
- Special Educational Needs and Disabilities (SEND) or additional support information (includes reasonable adjustments and special educational needs and disabilities)
- Attendance and reason for absence data
- Account access information
- Exam results and qualifications
- Progress reports
- Information relating to compliments and complaints
- Exclusion, suspension and behavioural information
- Right to work information.

We may also collect or use the following special category information. This information is subject to additional protection due to its sensitive nature:

- Racial or ethnic origin
- Religious or philosophical beliefs
- Health information
- Sexual orientation information.

We may collect or use the following information for disciplinary investigations or in response to requests from certain third parties such as law enforcement agencies:

- Names and contact details for learners
- Gender
- Pronoun preferences
- Special Educational Needs and Disabilities (SEND) information (includes reasonable adjustments and special educational needs and disabilities)
- Attendance and reason for absence data
- Witness statements and contact details
- Records and reports
- Call/video call recordings.

We may collect or use the following personal information for dealing with queries, complaints or appeals:

- Names and contact details
- Addresses
- Payment details
- Account login or user information
- Purchase or service history
- Call/video call recordings
- Relevant information from previous investigations
- Correspondence
- Special Educational Needs and Disabilities (SEND) or additional support information (includes reasonable adjustments and special educational needs and disabilities).

We may collect or use the following information for information updates or marketing purposes:

- Names and contact details
- Addresses
- Marketing preferences
- Website and app user journey information
- Records of consent, where appropriate.

## Lawful bases and data protection rights
